SOUTHWARK LGBT NETWORK

Southwark Lesbian Gay, Bisexual and Transgender Network (Southwark LGBT Network) is an unincorporated association founded in 2002. Its purpose is to build and strengthen LGBT communities in Southwark so as to improve the quality of life of LGBT people who live, work, study or socialise in Southwark, and reduce our vulnerability to hate crime, harassment and discrimination. The Network's work complements that of the Southwark LGBT Forum (formerly the Southwark Anti-Homophobic Forum).

Members, Officers and Executive Committee

The Network's constitution provides for individual membership and membership by affiliation. The fee for individual members is £1 and for affiliates £5. The Network currently has 92 individual members and 3 affiliates. The corresponding figures in last year's annual report were 21 individual members and no affiliates.

MAIN ACTIVITIES

The main activities of the Network this year have been to organise monthly events at Woolfson and Tay and, for the second year running, to give small grants for LGBT History Month.

Monthly events: These started in February 2012 and are held on the first Wednesday of the month at Woolfson & Tay. We are very grateful to all the speakers and performers, who are giving their time without charge, and to Peter Vittles and Carol Vincent for organising the events.

History Month 2012: For the second time small grants were offered to individuals and groups wishing to put on History Month events or activities in Southwark. Last year we were partnered by Southwark Council, but this year their budget extended only to organising a launch event (Queer Question Time) and they were unable to contribute to the small grants scheme. Grants totalling £4,135 were offered to 11 different groups and individuals. The comparable number last year was eight.

OTHER ACTIVITIES

'4 in 10': The Network has continued to mentor 4 in 10, the LGBT service-user group for the South London and Maudsley NHS Foundation Trust (SLaM). The group have recently applied successfully to the SLaM charitable trust for funding to employ a development worker.

Southwark LGBT Forum: Our sister organisation, the Forum, has been without a Chair since September. Gaby Charing stepped in as acting Chair. We are seeking a new Chair for the Forum, who will also be a member of the Network EC.

Communications: During the year the Network has acquired two new Web sites, one public-facing, the other for Network members only. We took over the LGBT email list from the Council. It had 150 email addresses on it. It now has 450. The EC has started to develop a communications strategy, but this area of our work is underdeveloped and we badly need someone with experience in communications to help us take it forward.

The EC agreed a strapline for the Network: Southwark LGBT Network - making our community count.

Fundraising: This is a priority for the coming year. As a minimum, we need to find a new funding partner for the small grants scheme.


Governance: No work has been done on the long-term legal structure of the Network as this seemed premature. It needs to be addressed in the coming year.

Other organisations: In addition to our work with the Forum and 4 in 10, the Network now has links with the Forum for Equalities and Human Rights in Southwark (FEHRS).

The Network donated £499.98 to 17-24-30 for the purchase of two gazebos for use during the vigil against hate crime held every year in Trafalgar Square. It was a condition of the grant that the gazebos be made available for use by other LGBT groups, and most particularly by LGBT groups in Southwark.

Network EC: The Network EC has met six times. All meetings have been quorate and indeed well attended, demonstrating the commitment and enthusiasm of EC members. The EC currently meets in members' homes. This avoids the expense of room hire, and creates a congenial atmosphere. Every effort is being made to keep the Network's running costs to a minimum.

With the exception of Gene Dugan-Brause, who has moved away from the borough, all officers and EC members are offering themselves for re-election, with some change in responsibilities. We are very grateful to Gene for his contribution over the past two years.

Treasurer's Report 6th June 2012

The Network's financial year runs from 1st April to 31st March. However, this report shows the financial position as at 25th May 2012.

In the past year the Network had no income save small amounts from membership fees, donations and bank interest.

Expenditure included the following: running costs of the Network; Network events; History Month small grants; and a grant of £499.98 to enable 17-24-30 to purchase two gazebos for use at the third annual vigil against hate crime in Trafalgar Square. The gazebos are available for use by the Network and other LGBT organisations.

All our assets are allocated to the Network's general fund, to be applied for the general purposes of the Network. We have no restricted funds, that is to say, funds donated for a specific purpose which may only be used for that purpose.

The Network has liabilities of £1,200, being grants for HM 2012 not yet claimed. The grant to Gendered Intelligence is not included, because their project is, sadly, unlikely to go ahead in the foreseeable future.
